- 1. Balance being carried forward from previous month;
- 2. Transactions made before the account was cancelled or were posted to the account after account cancellation;
- 3. Recurring transactions made through Direct Debit Authorization with merchants and / or "Octopus Automatic Add-Value Services". Please instruct the merchants (where applicable) to stop using this account as a payment account;
- 4. Interest being accrued to your account because of Cash Advance Transaction(s) and / or partial payment made in the previous month.

For your maximum protection, please cut your credit card in halves before disposal or you will be responsible for any unauthorized transactions before the card expires.
