Standard Chartered lowers its HKD Best Lending Rate

30 October 2025, Hong Kong – Standard Chartered Bank (Hong Kong) Limited announces that its HKD Best Lending Rate will be reduced by 12.5 basis points to 5.25 percent per annum from 5.375 percent per annum.

Its HKD savings deposit rates will also reduce to 0.001 percent per annum from 0.125 percent per annum.

The new rates will become effective on 3 November 2025 (Monday).
