**Standard Chartered Hong Kong to adjust branch services in response to the latest pandemic situation**

**5 February 2022, Hong Kong** – In light of the deteriorating COVID-19 situation in Hong Kong and to align with the government’s latest anti-epidemic measures, Standard Chartered Bank (Hong Kong) Limited (“Standard Chartered Hong Kong”) announces that it will reduce its branch services from 8 February to 25 February. During these three weeks, bank branches listed in the table below will be temporarily closed. This arrangement can help to reduce social contact and to prevent further spreading of the virus in the community, thus safeguarding the health of our clients and the employees.
