## **Important Note in relation to Annual Fee Waiver Criteria**

Dear Cardholders,

With effect from 1<sup>st</sup> June 2021 (the “Effective Date”), the annual fee waiver criteria for Standard Chartered Priority Banking Credit Card shall be amended as shown in the following table. The changes shall apply from the first anniversary of the issuance date of the relevant credit cards on or after the Effective Date. Clients who fail to meet the requirement will be charged with annual fee for Standard Chartered Priority Banking Credit Card.

Standard Chartered Priority Banking Credit Card 360° Rewards Programme Terms and Conditions	<p>Cardholders will enjoy an annual fee waiver on their Cards for a year (beginning from the respective anniversary of the issuance date of their Cards) if they are Priority Banking clients meeting the relevant Minimum Relationship Balance requirement as stipulated by the Bank from time to time. Cardholders are entitled to the above stated annual fee waiver so long as they meet the above stated criteria in the annual fee billing month.</p> <p>The above annual fee waiver condition will be included as a new Clause 1 in Standard Chartered Priority Banking Credit Card 360° Rewards Programme Terms and Conditions. All subsequent clauses shall be renumbered accordingly.</p> <p>For details of the applicable annual fee, please refer to the Credit Card Key Facts Statement.</p>

The above changes shall be binding on you if you retain or continue using your Card(s) on or after the effective date as shown above. Please be advised that we may, however, not be able to continue to provide the services to you if you DO NOT wish to accept the above changes.
